## Smoking/alcohol/drug policy for rental groups

### *SMOKING POLICY*

#### **NO SMOKING IS PERMITTED INSIDE ANY BUILDING AT CAMP AT ANY TIME**

For the purpose of this policy, the term “smoking” includes, but is not limited to, the use of tobacco cigarettes, cigars, vape, vape pens, cannabis, Juul, etc.

All smoking materials must be disposed of in an approved container to reduce the risk of fire and to prevent littering and pollution of the water.

- Smoking by minor campers (under the age of 19) at Camp Artaban is strictly prohibited.
- Smoking by adults at family and adult camps will be permitted only in the designated area at the south end of the wharf.
- For the safety of minors and other campers, smoking products must be stored securely in your personal belongings, out of sight and with no access by minors and other campers.
- Adult campers violating this policy may be asked to leave camp at their own expense.

## Alcohol/Drugs policy

### *ALCOHOL/DRUG POLICY*

Illegal drugs will not be transported, stored on site or consumed during any Artaban event by anyone, at any time, whether camper, volunteer or paid staff.

Alcohol will not be consumed at camp by anyone under the age of 19 whether camper or staff.

- Alcohol will not be transported, stored on site or consumed except by adults 19 years of age and older
- Alcohol is to be consumed only in designated areas depending on the type of rental contract situation. During family/group camping rentals, alcohol is to be consumed only in the family/group’s designated camping area or

cabin. For special events such as weddings, alcohol may be permitted in designated areas such as the dining hall, as per the rental contract.

- No alcohol is permitted at the waterfront at any time.
- Alcohol must be stored in your campsite area/accommodation unless other arrangements have been made ahead of time in the rental contract.
- For the safety of minors and other campers, alcohol products must be stored securely in your personal belongings, out of sight and with no access by minors and other campers.
- Alcohol must be used responsibly and in moderation.
- Empty containers and bottles as well as any remaining alcohol must be taken off site by the renters when they leave the camp.
- Adult campers violating this policy may be asked to leave camp at their own expense.

## **Cannabis Policy**

### ***CANNABIS POLICY***

**Cannabis products will not be smoked, vaped, or consumed at camp by anyone under the age of 19, whether camper or staff. Smoking/vaping will be subject to the smoking restrictions.**

- Cannabis use by minor campers (under the age of 19) at Camp Artaban is strictly prohibited.
- Cannabis use by adults at family and adult camps will be permitted only in the designated area at the south end of the wharf.
- Smoking or vaping cannabis is permitted only in the designated smoking area.
- Consumption of cannabis products is not permitted with children present and must be confined to your camping area/accommodation
- Cannabis products must be stored in your campsite area/accommodation unless other arrangements have been made ahead of time in the rental contract.
- For the safety of minors and other campers, cannabis products must be stored securely in your personal belongings, out of sight and with no access by minors and other campers.
- Adult campers violating this policy may be asked to leave camp at their own expense.
